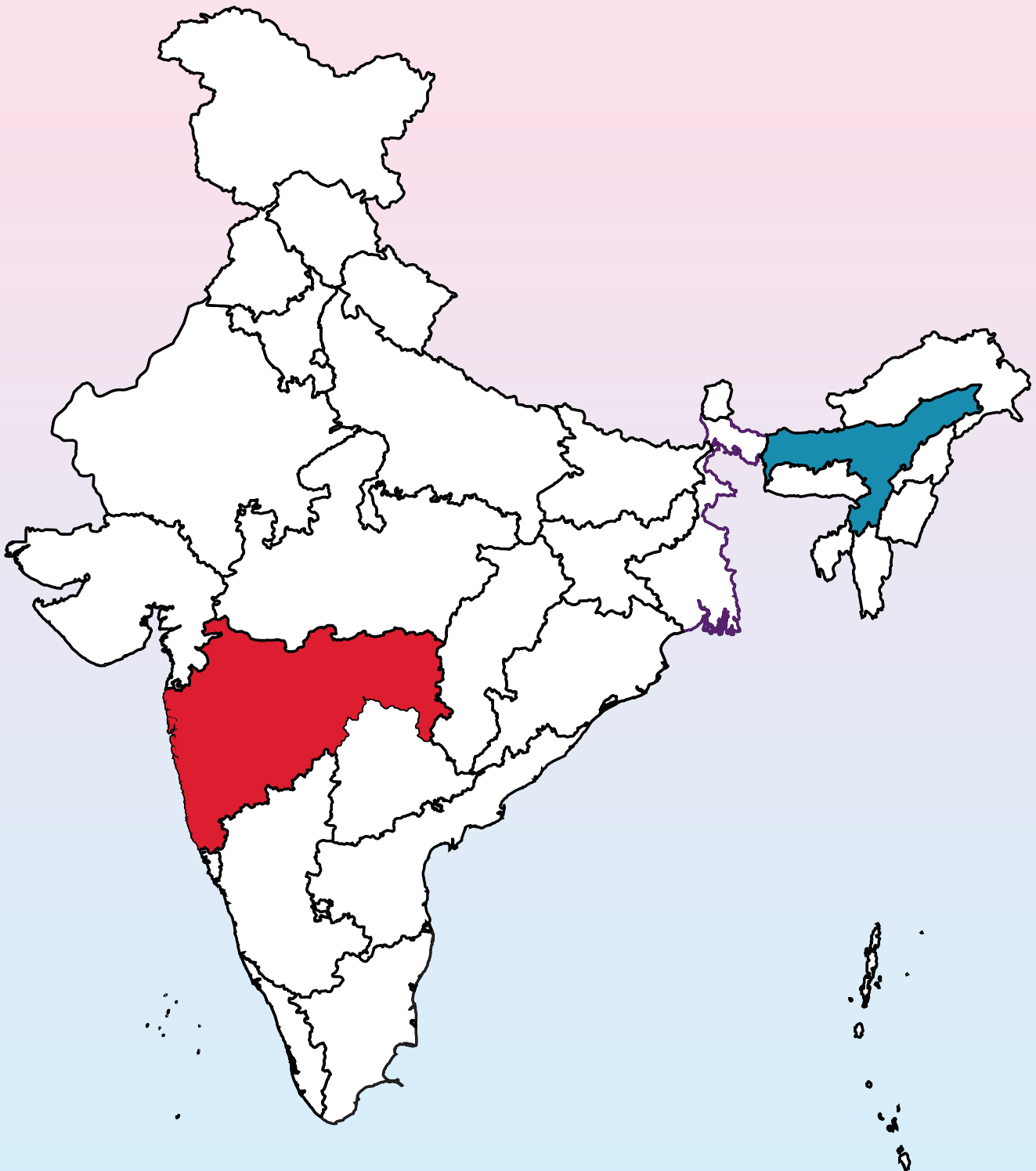

Education is fundamental to this, as this is the only way of ushering in sustainable change and reducing intergenerational poverty. We also create awareness through advocacy regarding the long-term socioeconomic benefits of education in rural communities.

Providing quality emergency medical care for children is another issue that we hope to focus on. Many children with congenital heart diseases, cancer or those requiring immediate hospitalisation in rural and semi-urban communities are either financially distressed or are just unable to afford the cost of treatment due to low income. We will raise resources for such children and ensure that they receive quality medical care.

Although the Government of India has championed the cause of sanitation through the Swachh Bharat Mission (SBM) and Swachh Bharat Abhiyan (SBA) a lot more needs to be done to ensure the availability of gender-specific toilets and potable water in schools. Many adolescent girls drop out of schools due to the non-availability of toilets. Through our sanitation support programmes in collaboration with corporate houses we will facilitate the provision of gender-specific toilets and potable water in schools across Maharashtra.

We hope to make India a safer and better place for children from underprivileged and under-served communities by partnering with the corporate community, like-minded NGOs and civil society.

We would like to thank all our corporate and individual donors, our dedicated staff and all the volunteers who have helped make our programmes successful.

Facts about Congenital Heart Defects

Congenital heart defects (CHDs) are the most common congenital anomalies in the world, with an estimated prevalence of 9.1 per 1000 live births and are the leading cause of infant morbidity and mortality from birth defects. Surviving infants with CHDs who are not treated early, suffer from lifelong physical and mental comorbidities, posing substantial financial and psychological burdens on the family.



Facts about Paediatric/Childhood cancer

Paediatric cancer comprises almost 3-5% of the total cancer cases in India. According to the Indian cancer society, it is estimated that about 50,000 children and adolescents' will be diagnosed with cancer each year. The disturbing reality is that the cure rate of paediatric cancer is almost 80% in developed countries. Since the treatment is only available in premium institutes, families who don't have access to these institutes or are financially distressed are often diagnosed late when it becomes nearly impossible to cure.

Our Intervention:

Although the recovery rate from both Congenital heart defects (CHDs) and Paediatric cancer is high when detected and treated early, a majority of families with symptomatic children are underprivileged, this is compounded by the fact that in rural India where most of our population lives, the medical facilities are woefully deficient and for the poor, travelling to larger cities for prolonged treatment is a financial and logistical challenge.

The Baby Care Foundation interacts with social workers, NGOs and CBOs across Maharashtra to identify such children; furthermore, our medical coordinators regularly solicit updates regarding paediatric patients from the medical speciality departments of various partner hospitals and other hospitals to identify underprivileged children who need emergency medical treatment.

We contribute towards the medical costs of such children by resource mobilisation through various online and offline channels, and as the treatment is often prolonged for cancer, we provide ancillary support like counselling and livelihood support for the families and educational scholarships for children when they recover.



Reducing Malnutrition



Improving the overall Quality of Life in rural India has been the primary concern in the economic planning and development process since the past few decades.

The lack of awareness as well as illiteracy has taken a toll on the health of the people living in the tribal hamlets and rural areas of India. By facilitating the distribution of nutritional supplements to pregnant and lactating women in collaboration with the local PHCs in the proposed project area, this vicious cycle of intergenerational malnutrition can be drastically reduced.



In the rural areas of Maharashtra, the underlying cause of maternal malnutrition is child marriage. Due to out-dated cultural practices, girls as young as 13 get married. The health-care facilities in many areas of rural Maharashtra are either non-existent or skeletal. Specialist doctors do not want to practise in rural areas, and this only adds to the problem. A family officially identified as being below the poverty line (BPL) stands to receive anything from Rs. 8,600-Rs 9,900 a year towards food subsidy that amounts to approximately 25 rupees per day, in which even one nutritious meal is implausible. Micronutrients and supplements are seldom distributed and this leads to many deficiencies in both mothers and their children. The main hurdle in improving the living conditions for women in children in these areas is increasing the level of awareness in a community that is largely uneducated and thus resistant to change.

In India, infant mortality and malnutrition among young children below the age of five is due to greater susceptibility to infections. This correlation is most visible in rural communities and BPL families. Research has proved that the chronic effects of malnutrition can be reversed by providing nutritional supplements in the first few years of a child's life. To stem the transmission of intergenerational malnutrition, children who are at risk must be attended to with urgency and on a pan-India level, as a majority of Indians still live in rural and semi-urban areas.

Children who suffer from malnutrition are always underweight and seldom reach their optimum height; besides, it also affects their brain development, resulting in lower IQs, delayed enrollment, higher absenteeism and more class repetition.

Through its advocacy and awareness programmes and by facilitating the provision of nutritious meals in Anganwadis, The Baby Care Foundation aims to reduce child and maternal malnutrition in rural India.



Menstrual Hygiene Management



Menarche or the onset of puberty in girls signifies their passage into womanhood. This is an inevitable biological process that is still considered taboo in Indian society and this prevents many young girls on the threshold of puberty from learning about their bodies and discussing issues related to it. Due to this mindset, which is inculcated in them from their childhood, hygiene management during menstruation is ignored, which results in adverse health outcomes. If menstrual hygiene is not given importance, it raises the risk of reproductive tract infections, cervical cancer and also affects fertility. Motivation plays a very important role in the adoption of hygienic practises during the menstrual cycle.

Even today, in many parts of our country, adolescent girls and women are not allowed into kitchens, temples, etc. These taboos and cultural restrictions are largely due to limited knowledge and access to information, both at home and in schools. As a result, girls often do not know what to do, when they begin menstruating. Through its advocacy sessions on menstrual hygiene, The Baby Care Foundation curbs the myths and misconceptions regarding the menstrual cycle and spreads the correct message of hygiene among communities. This ensures that girls and women have the right answers to all their intimate questions and thus they do not have to suffer the consequences of poor menstrual hygiene. This programme is in consonance with SDG 6 of the UN Goals.

Access to all elements of WASH are necessary for menstrual hygiene management (MHM). Girls attending schools with functional gender-specific toilets that provide a private place to wash and change and a reliable supply of water and soap are much more likely to be able to manage their periods with confidence and dignity. Realising this, we facilitate the provision of sanitation facilities in schools, conduct awareness sessions on MHM, and regularly distribute free sanitary napkins to adolescent girls and women from underserved communities.





School Sanitation Programme (WASH)



According to the 13th Annual Status of Education Report (ASER) Rural 2018, around 22.8% of rural schools surveyed in India have unusable toilets. This citizen-led survey, which was released on January 15, 2019, studied the status of elementary education in rural India, and, one of the elements it looked into was sanitation and child health.

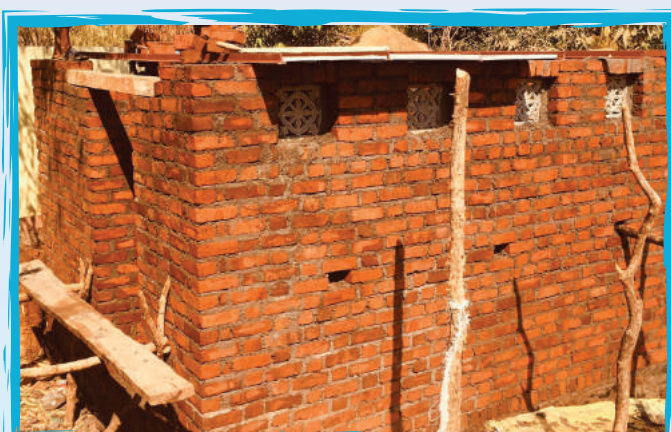
The study finds that bad infrastructural development, ownership issues, lack of motivation or lack of maintenance are the reasons why these toilets were unusable. When it comes to providing proper sanitation facilities to female students, schools in rural India still have a long way to go. Despite the government launching the “Swachh Vidyalaya” initiative under the “Swachh Bharat Abhiyan”, 11.5% of rural schools still do not have separate toilets for girls.

There is a direct correlation between access to clean gender-specific toilets in schools and educational outcomes. Even as recently as two years ago, nearly 30% of the 1.5 million schools in India lacked toilets; the percentage was even higher when looking at usable washrooms specifically for girls.

The issue becomes even more complex in rural scenarios; wherein many students are first-generation learners who have yet to derive or understand the long-term benefits of education. In a predominantly archaic patriarchal system, there is still a reluctance to send girls to school, a lack of separate toilets aggravates the problem. This especially deters adolescent girls from continuing their education. The result of this is intergenerational illiteracy, which prevents a major percentage of India's young population from being a productive workforce.

Statistics obtained from both government and non-governmental agencies prove that constructing usable and clean latrines in schools decreased dropout rates; reducing the fraction of students who dropped out by 5.3% in the middle schools and by 12.2% in primary schools. There is irrefutable evidence that a lack of clean toilets and potable water increases the risk of waterborne diseases, urinary tract infections and absenteeism. A clean toilet is perhaps the biggest motivation for a student to continue schooling, especially during adolescence.

The Baby Care Foundation strives to construct gender-specific toilets and provide potable water through corporate partnerships to schools in rural areas to improve health and hygiene, improve enrolment and retention rates of female students and thus improve educational outcomes.

Education Support Programme



Education is a fundamental human right enshrined in several international and national protocols, conventions, and treaties and needs to be observed and exercised with the utmost commitment. The efforts being made by the government of India to ensure Universal Basic Education are praiseworthy, but a lot more still needs to be done to ensure 'good education for all' to achieve the SDGs particularly the Education for All (EFA) goals in consonance with SDG 4. Although the Right to Education is a Constitutional mandate in India, it has unfortunately never been implemented properly and thus inclusive education has still not permeated into rural and semi-urban communities in India where most of our population lives. This has especially affected the girl child, as a lack of education among girls leads to other social evils like early marriages and inter-generational illiteracy.

We at The Baby Care Foundation firmly believe that we can inculcate a positive life-changing influence in underprivileged children from underserved communities and ensure a protected and promising future by empowering these children through education. There is an urgent need to introduce the concept of holistic education in schools; while academics have to be stressed upon, the overall development of the child is equally important to ensure that he or she has the right skills to tackle the challenges of life and be a success. Holistic education at the primary school level leads to better self-governance, higher self-esteem, and overall emotional development. Through our vocational training programmes, we will impart industry-specific skills, which will enable youth to gain employment once they finish schooling or college thus contributing to the country's economy.

We have conducted various camps and workshops in different regions to make communities aware of the importance of education and its long-term socio-economic benefits to society. This involves convincing the parents to enroll their children through advocacy and if the families are financially distressed, we provide educational scholarships and stationery to these students. We also facilitate the provision of bridge-courses to enable re-enrolled dropouts to achieve age and class appropriate competency levels and provide free computer training to students from 4th to 10th standards, this ensures that they are technically as proficient as their peers in private schools.

Sports Equipment Distribution

Although academic excellence and life-skill training have to be given utmost importance, extra-curricular activities like sports, play a very important role in holistic education. Activities like sports improves the fitness levels of children thus improving their immunity; it gives them a chance to develop their social skills, meet new friends and become more confident while communicating in groups. Extracurricular activities can also aid in the development of self-esteem and confidence. The Baby Care Foundation regularly distributes sporting equipment in schools where children from underprivileged and underserved communities study.





Education Support Programme



SUCCESS STORY 1: Ankita U Vetel comes from a humble family; her father Umesh has a small business, while her mother is a homemaker. Although the family was financially distressed, with daily survival being the priority, Ankita a first-generation-learner was determined to excel in her SSC board exams, but was unable to concentrate on her studies. She feared that as her fees was pending, the school would not let her appear for the exams.



The Baby Care Foundation realised the potential of the girl and supported her through an educational scholarship; we also ensured that she had adequate stationery and study material. Ankita secured a good percentage in her board examinations and is now in junior college. She wants to become a teacher after her graduation. In the same year, we also provided a scholarship to her younger brother Vedant, who was then studying in the 5th standard; he now continues to excel in his studies. The Vetel family is extremely grateful to The Baby Care Foundation for supporting the education of their children.

SUCCESS STORY 2: Suyash Mhatre's father Sadanand is a farmer who grows vegetables and millet on a small patch of leased agricultural land while his mother is a homemaker. The family struggles to make ends meet as the proceeds from the sale of the agricultural produce barely manages to support the large family.



Suyash showed a lot of promise and despite the drawbacks, continued to study with great dedication; but was mentally disturbed as the school kept sending reminders about pending fees. The Baby Care Foundation decided to intervene and provided the boy with an educational scholarship; we also ensured that he had adequate stationery, study material and access to counselling. Suyash has passed his SSC board examinations with flying colours and wants to become a doctor in the future. Mr and Mrs Mhatre are extremely thankful to our NGO for supporting their child's education and paving the way for his future.

We at The Baby Care Foundation firmly believe that education is the most empowering force in the world. It creates knowledge, builds confidence, and breaks down barriers to opportunity. For children, it is their key to open the door to a better life. All children deserve to receive the 'precious gift' of education. And we will continue to strive towards this goal.

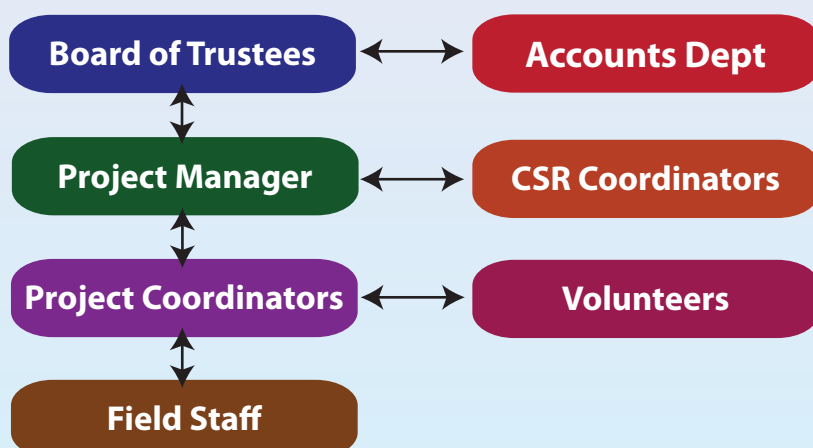

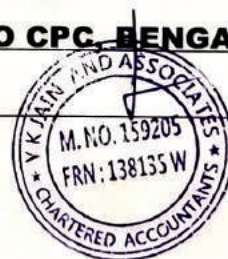

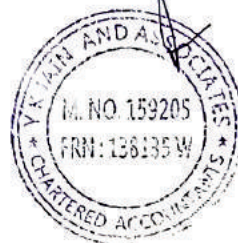
